GREG ANRIG, JR. is vice president of programs at The Century Foundation, supervising the creation and progress of the foundation's projects. KATHERINE FENNELLY is professor of public affairs at the Hubert H. Humphrey Institute, University of Minnesota, and the 2006-2007 Fesler-Lampert Chair in Urban and Regional Affairs. Her research, teaching, and outreach interests include immigration and public policy, leadership in the public sector, the human rights of immigrants and refugees in the United States, and the preparedness of communities and public institutions to adapt to demographic changes. She has been dean of the

University of Minnesota Extension Service, a faculty member and department head at the Pennsylvania State University, and a faculty member at Columbia University School of Public Health. She is bilingual in Spanish and English, and has worked and traveled extensively throughout Latin America.

LOURDES GOUVEIA is director of Latino/Latin American studies and professor of sociology at the University of Nebraska at Omaha. She has published numerous articles on the interrelation between the global restructuring of meat processing, the recruitment of Latino immigrant labor, and the implications of these changes for the future of Latino immigrant labor flows and their communities of settlement. She is coeditor of *From Columbus to ConAgra: The Globalization of Agriculture and Food* (University Press of Kansas, 1994).

MARK A. GREY is professor of anthropology at the University of Northern Iowa and director of the Iowa Center for Immigrant Leadership and Integration. He has published extensively in academic journals on immigration in the Midwest. He is the author of *Welcoming New Iowans: A Guide for Citizens and Communities*, *Welcoming New Iowans: A Guide for Managers and Supervisors*, *Welcoming New Iowans: A Guide for Christians and Churches* (with Dr. Anne Woodrick), and *Health Matters: A Pocket Guide for Working with Diverse Cultures and Underserved Populations* (with Michele Yehieli). He has won numerous awards for his activities, including the Iowa Friends of Civil Rights Award and the Iowa Council for International Understanding Vision Award.

PAULA D. MCCLAIN is professor of political science, public policy, and African and African American studies at Duke University. She is currently president of the Southern Political Science Association, director of the Ralph Bunche Summer Institute, and codirector of the Center for the Study of Race, Ethnicity and Gender in the Social Sciences. She is a past vice president of the American Political Science Association and a past president of the National Conference of Black Political Scientists. She is the author (with Joseph Stewart, Jr.) of *"Can We All Get Along?" Racial and Ethnic Minorities in American Politics* (Westview Press, 2005). Her most recent articles have appeared in the *Political Research Quarterly*, *Journal of Politics*, *American Political Science Review*, and *American Politics Quarterly*.
